TERMS AND CONDITIONS

The following Specific and General Conditions for Participation in ICCI 2016 become legally binding in all points with the exhibitor's application to the event. They form the legal basis regarding participation in the event.

1.1- PARTIES OF THE AGREEMENT

On the one hand, SEKTÖREL FUARCILIK A.Ş (to be referred as SEKTÖREL FUARCILIK from this point onwards) at the address of Büyükdere Cad. Sarlı Is Merkezi No: 103B Blok Kat. 5-6 34394 Mecidiyeköy / İstanbul - Turkey and on the other hand, the exhibitor stated on Form F1 (to be referred to as "Customer" from this point onwards).

1.2- EVENT LOCATION AND DATE

İstanbul Expo Center Halls 9-10-11. Dates: 27 - 29 April 2016

1.3- ORGANIZATION

ICCI - 22nd International Energy and Environment Exhibition and Conference will be referred to as ICCI from this point onwards and will be organized by Sektörel Fuarçılık A.Ş (In the agreement text, company's title will be used as "SEKTÖREL FUARCILIK".)

1.4- SUBJECT OF THE AGREEMENT

The subject of this agreement is to set the conditions for participating in the ICCI - 22nd International Energy and Environment Exhibition and Conference (to be referred to as ICCI from this point onwards) that will be organized by SEKTÖREL FUARCILIK at İstanbul Expo Center between 27 - 29 April 2016.

1.5- PROVISIONS

Article 1: SEKTÖREL FUARCILIK is obliged to provide to its Customer, the exhibition area with specific sizes as indicated in the participation agreement. Customers are allowed to exhibit their products and services only within the premises of their allotted exhibition area. The Customer can in no way rent this exhibition area to other persons or companies. The Customer cannot exhibit products or services other than those indicated to SEKTÖREL FUARCILIK. (Form F3) Otherwise, SEKTÖREL FUARCILIK will have the right to remove these items outside the exhibition venue.

Article 2: The Customer can exhibit at its stand, the products and services of companies for which it has no dealership, only in the "Sub-participant" category.

In this case, the Customer has to pay an additional participation fee of 3.000 € + VAT per company/product/service. If the Customer has products or services of another company to exhibit as a "sub participant", the form included in the ICCI 2016 Participant Hand Book should be filled out and sent.

- The sub-participant has the same obligations as the main participant and is deemed to have accepted all provisions of this agreement.
- The main participant is the debtor and joint guarantor of the event participation fee to be paid by the sub-participant.
- If a sub-participant joins the event without due approval of SEKTÖREL FUARCILIK, then SEKTÖREL FUARCILIK will have the right to unilaterally terminate its agreement with the main participant without having to notify the participant and to remove the items of the participant from the stand with cost of such removal belonging to the participant company. In such a case, the main participant will have no right to demand any compensation.
- The sub-participants are all participants who, together with the main participant, are represented with their personnel and products at the same stand.
- Companies that are related or known to be within the same group of companies will be considered to be sub-participants.
- The sub-participants which have sent the required documents to SEKTÖREL FUARCILIK until the deadline, made a request as a sub-participant and have paid all their fees can be included in the catalog with their addresses.
- Group stands that are in harmony with the general style of the exhibition can be approved.
- If a certain stand has been allotted to two or more companies, each company, both collectively and separately, is obliged towards SEKTÖREL FUARCILIK, to act in line with the participation conditions.
- Participant companies that join the event with a group stand will be indicated under the "group name" in the catalog and company names and information of these participants will not be listed separately.
- In case the main participant company cancels its participation, the participation of the sub-participant as well will be automatically

Article 3: The smallest exhibition area to be rented is 9 m². Smaller areas can only be rented on the basis of availability after the final lay out plan is confirmed.

Article 4: When customers who have accepted to participate in the exhibition by signing an agreement, notify SEKTÖREL FUARCILIK about their decision not to participate in the event via a notary certified written notification within at most 15 days after the signing of this agreement, they will not be obliged to make any payments to SEKTÖREL FUARCILIK. If the customer sends such notification after the above mentioned 15 day grace period or a date after 5 months before the event, the customer will be obliged to pay 75% of the participation fee. In any case, the customer has no

right to send such notification for cancellation or decide not to participate after 3 months before the event. In such a case, the Customer will be deemed to have participated in the event and will be obliged to pay to SEKTÖREL FUARCILIK in full and in accordance with the conditions set forth herein, the exhibition participation fee even if the Customer has not been physically present at the event.

Article 5: "Payment Plan" section of the participation agreement (Form F2) expresses an undertaking on behalf of the Customer as to the method of payment and is binding. SEKTÖREL FUARCILIK will have the right to obtain postdated checks from the Customer. In case any of the payments in the payment plan are not made on time or not paid fully, all payments will fall due and SEKTÖREL FUARCILIK will have the right to demand interest for unpaid balances effective from the agreement date.

Article 6: The amounts indicated in this agreement and has to be paid to SEKTÖREL FUARCILIK by the Customer are given in Euros and advance payment and installment amounts are given in TL equivalent based on effective foreign exchange rates of the Central Bank of Turkish Republic. In case a foreign exchange rate differential to occurs between the opening date of the exhibition and the agreement date, SEKTÖREL FUARCILIK will have the right to charge this differential to the Customer via an invoice.

All payments need to be completed by the 10th date before the installation starting date. Payment dates on payment documents such as cheques, payment bonds, etc. cannot go beyond that date. Companies that do not comply with these conditions will not be able to participate in the exhibition.

Article 7: It is not possible to request an exhibition space by any means other than the participation agreement. to SEKTÖREL FUARCILIK has the right to change the location of the exhibition venue, the location of the stand and its size without having to pay any compensation.

Article 8: At the end of every exhibition day, the stands will be returned to the security personnel of the event and will be returned back to the stand personnel one hour before the event start on the other day. In case the Customer acts on the contrary, the Customer will be directly liable for any damage caused to the Customer itself and any 3rd party.

Article 9: In case the customer fails to fulfill any of the payment undertakings as mentioned in the agreement, SEKTÖREL FUARCILIK will have the right to unilaterally terminate the agreement and demand from the Customer, the payment of due amounts in addition to compensation for all material and immaterial loss if any.

Article 10: SEKTÖREL FUARCILIK has the right to make changes to the layout project of the event. SEKTÖREL FUARCILIK is obliged to notify the Customer in writing, about the changes made and the new layout plan. If the Customer opts to quit the event, the Customer will notify SEKTÖREL FUARCILIK about the issue and will be able to quit the event only after written consent of SEKTÖREL FUARCILIK is obtained. If the Customer fails to follow this procedure, SEKTÖREL FUARCILIK will have the right to demand the full amount of participation fee from the Customer. SEKTÖREL FUARCILIK will have no undertakings or responsibility towards other Customers as a result of this decision.

Article 11: The Customer is obliged to use the allotted exhibition space as indicated in the agreement, without causing any damage to it. It is forbidden to drill the walls, panels, aluminum materials and other fixed materials and to nail, paint, use adhesive products other than two-sided adhesive tape and to give damage to fixed areas of the exhibition venue. Otherwise, the Customer is obliged to pay in cash, any damage given by the Customer itself. The Customer will not be allowed to take its products and services out of the exhibition venue without compensating for such damage in cash.

Article 12: The exact dimensions of the exhibition space provided to the Customer by SEKTÖREL FUARCILIK are given in the agreement. The projection of any point on the stands can in no way extend beyond the corridor. Otherwise, the Customer will be obliged to redesign the stand to meet the relevant criteria before the start of the event.

All due expenses incurred during this process will be charged in cash in return for an invoice from the Customer causing the breach.

Article 13: Exhibitors who applied for a raw space have to have their stands designed and built by either themselves or 3rd party contractors. The Customer is obliged to have the project for the stand decoration in 3D format approved by SEKTÖREL FUARCILIK 45 days before the start of the event. SEKTÖREL FUARCILIK has the right to change those aspects of these projects that fail to satisfy the criteria for approval or match the general layout of the venue. Maximum stand height allowed is 5.00 meters when SEKTÖREL FUARCILIK gives consent after an inspection. Customers whose projects have not been approved will not be allowed to mount their stands and bring their products to the venue. Side stands height should be 3.50 meters at most.

Article 14: SEKTÖREL FUARCILIK has the right to intervene the mounting works of unapproved stands or to have them removed if already mounted. In order to prevent construction disharmony with neighboring stands, the owners of these stands should be in contact with each other. SEKTÖREL FUARCILIK assumes no responsibility for construction disharmony. Of the two adjacent stands, the higher side of the higher stand on the side of the lower stand should be covered with an appropriate material.

Article 15: The Customer is obliged to communicate to SEKTÖREL FUARCILIK, the names and contact information of the representatives of the third parties (such as for the sound system, architecture etc.) that provides stand construction support to the Customer along with the projects listed in Article 14.

Article 16: The Customer is obliged to communicate to SEKTÖREL FUARCILIK at least 45 days before the event the names of the companies that will support the Customer during stand mounting and throughout the event, and their respective tasks and obtain approval for these companies and these tasks as well. Otherwise SEKTÖREL FUARCILIK will have the right to refuse to allow these companies to occupy the exhibition venue or work in there. Hereby, the Customer unconditionally accepts this condition.

Article 17: If the stand wall on the side of the corridor is 3 meters or higher, there should be an at least 1 meter gap between this corridor and the stand border. Otherwise, SEKTÖREL FUARCILIK will have the right to take action on the basis of Article 13.

Article 18: The Customer is obliged to inform SEKTÖREL FUARCILIK about audio and video based performances to be organized inside the exhibition venue. If a visual show is to be performed, the reflection of this performance must not extend beyond the stand area. If loud speakers are to be used inside the exhibition area, these speakers should be facing inside the stand. Otherwise SEKTÖREL FUARCILIK officials will have to change the orientation of these speakers as required. Maximum sound level measured at 1 meter from the stand border should be 85 dB. Otherwise the Customer will be warned by SEKTÖREL FUARCILIK. If no response is received from these warnings, SEKTÖREL FUARCILIK will have the right to stop supplying power to the stand of that Customer for 1 hour. SEKTÖREL FUARCILIK does not assume responsibility for any damage that might be incurred during this power outage. On the other hand, it is the Customer who shall be responsible for any damage to the general electricity system of the exhibition venue during this power outage.

Article 19: If corridors or other stands get over crowded due to the shows to be performed by the customer in the stand area, SEKTÖREL FUARCILIK will have the right to intervene and stop the performance if necessary. SEKTÖREL FUARCILIK has the exclusive right to organize audio and visual performances (such as radio, TV...etc.) on all indoor and outdoor sections of the exhibition venue. Broadcasting equipment or vehicles without any permission will not be allowed inside the venue. SEKTÖREL FUARCILIK also has the right to record the stands, activities and product exhibitions via video recorders, cameras or drawing and to use them for promotional purposes.

Article 20: Fair ground rents have been determined per square metre, according to the type of application, containing the components given below:

Rent amount for 1 m² Special Exhibition area is without stand and includes:

Fair unit price indicates the empty area rented without a stand. The services included in this price are given below.

- Defining the exhibition space (m²) and its location,
- Advertisement and promotion of the event,
- Services of the Information Desk and Technical Service Offices,
- Providing the services for the general security and cleanliness of the exhibition venue (internal stand area cleaning is the responsibility of the customers only for Special Design Stands).
- Printing and distribution of the fair catalog / CD and promotional brochures.
- 4 KW electricity will be provided for special design booths that hasn't requested electricity amount in a written way until April 13, 2016 regardless of their sqms. Electricity connection is going to be changed in accordance with the tariff stated in article 38.

For extra services other than those sited above, the Customer has to make a request by filling the relevant form in the Participant Hand Book in addition to the ICCI Participation agreement and the Customer has to pay the additional fees arising from these extra services.

The rent amount for the exhibition space is given for a unit of 1 m².

Fair unit price indicates the area rented with a standard stand. The services included in this price are given below, according to the types indicated below, in addition to the services offered with Custom Design Stands.

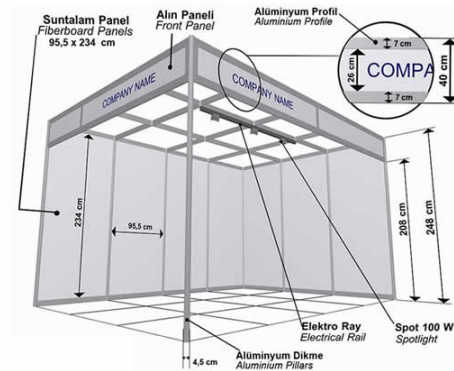

Article 21: If a second storey is to be constructed on top of the regular stand area, it should not exceed standard height of 5 meters. This height limit is 3,5 meters for side stands.

Article 22: Internal decoration of the stand and related costs will be the responsibility of the Customer.

Article 23: The Customer must show necessary care in order not to let the exhibition stand block fire-hose cabinets. The locations of the fire cabinets are indicated in the layout plans.

Article 24: Exhibition venue is under general insurance coverage by SEKTÖREL FUARCILIK. This insurance covers damage by natural disasters, fire, leakage and flood. However this insurance does not cover the items to be displayed by the Customer. The Customer is recommended to buy insurance coverage for its own stand and products. SEKTÖREL FUARCILIK has no responsibility for any lost item.

Article 25: For companies whose stands will be constructed by SEKTÖREL FUARCILIK and companies who will build their own custom stands, SEKTÖREL FUARCILIK will notify the Customers about the entry and exit dates to the exhibition venue. From start of the entry to the venue until the exit from the venue, SEKTÖREL FUARCILIK will have complete authority on all issues inside the venue.

Article 26: The stand material to be used during construction should be brought to the exhibition venue ready to mount (cut in required sizes and painted etc.). Companies are not allowed to use the exhibition venue as a workshop or use compressed painting equipment. Additionally, the use of LPG, welding tubes or similar explosive materials is definitely banned on the exhibition venue. In case of any action on the contrary, venue security personnel will remove such items immediately out of the venue.

ARTICLE 27: In case a customer breaches any provision of the exhibition agreement, disrupts the peace of the event, makes additions to the leased exhibition space or brings unwanted materials into the exhibition venue, SEKTÖREL FUARCILIK has the right not to allow the exhibitors into the exhibition venue, not to allow the Customer to exhibit its products and to act on its own discretion without having to pay any compensation.

Without written consent of SEKTÖREL FUARCILIK, the participant companies are not permitted to allow 3rd parties (or companies, products, services, titles and brands of other companies) to utilize the exhibition space fully or partially in return for a fee or free of charge.

Article 28: Customer is entitled to 1 participant badge per 3 m² exhibition space. The Customer is required to communicate to SEKTÖREL FUARCILIK, the names, titles and company information of the personnel that will work at the stand. For applications made after the deadlines indicated in the Participant Hand Book, no badges will be provided and nobody will access the event under the "participant" title without this badge. Participant badge will be delivered to event official in return for signature.

Article 29: Customers are not allowed to print invitations without the permission of SEKTÖREL FUARCILIK. In case the Customer does so, SEKTÖREL FUARCILIK will have no responsibility. Each Customer will be entitled to 10 invitations per 1 m² of exhibition space. If the customers themselves wish to print invitations, they have to obtain written consent of SEKTÖREL FUARCILIK.

Article 30: The official Exhibition Catalog of ICCI 22nd International Energy and Environment Exhibition and Conference will be printed by SEKTÖREL FUARCILIK. When the Customer sends incorrect information to be printed in the catalog, SEKTÖREL FUARCILIK will have no responsibility. When a Customer fails to communicate required information, the Customer will have no right to argue that Customer's information was not included in the catalog.

Article 31: ICCI 21st International Energy and Environment Exhibition will be open for visit between 27 - 29 April 2016. The Customer can enter the venue at 9 a.m. at the earliest and leave at 8 p.m. at the latest. Item entry and exit, on the other hand, will be realized within the operation hours of the event and will be subject to approval by SEKTÖREL FUARCILIK. During the regular hours of the event, the Customer will be allowed to bring into the venue, only those items that can be carried by hand. Regular visiting hours of the event are 09 a.m. and 7 p.m. SEKTÖREL FUARCILIK has the right to change these times.

Article 32: Power supply to the stands will be cut 30 minutes after the closing time of the event. Customers who wish to carry out work in their stands after the closing time should notify SEKTÖREL FUARCILIK about the issue at least 3 hours before the closing time and obtain SEKTÖREL FUARCILIK's permission. On the last day of the event, 30 minutes after the closing time, general power supply of the venue will be cut due to security reasons. SEKTÖREL FUARCILIK assumes no responsibility for the above mentioned power cuts.

Article 33: The items of those customers who fail to leave the venue within the allotted time will be removed outside the premises without any notification. Any loss, damage or expense incurred during this process will be the responsibility of the Customer.

Article 34: SEKTÖREL FUARCILIK has the authority to give permission for catering services at the exhibition venue. The offerings to be made at the venue can be provided by the official catering company of the event or by the companies determined by exhibitors.

Article 35: SEKTÖREL FUARCILIK communicates "ICCI Participant Hand Book Passwords" to the customers. The Customer is obliged to fill the forms in the Hand Book and send them to SEKTÖREL FUARCILIK before the relevant deadlines. SEKTÖREL FUARCILIK will assume no responsibility for forms that were not sent or sent late. For requests sent after the deadline, SEKTÖREL FUARCILIK will charge 50% price differential over the original prices. In case the Customer makes no written objection about the services requested at the venue during the event dates, the Customer will be deemed to have received that service and will be liable to pay the relevant invoice amount.

Article 36: In case the services to be provided by SEKTÖREL FUARCILIK are requested after the deadline given in the ICCI Participant Hand Book, SEKTÖREL FUARCILIK cannot guarantee to provide these services.

Article 37: After the corridors in the venue are covered with carpets, SEKTÖREL FUARCILIK will not allow vehicles that might damage the venue floor such as forklifts, pushcarts or palletted vehicles to enter the venue.

Article 38: All technical services (such as phone, electricity, water, pressurized air, internet etc.) and other services to be provided at the venue will be provided in return for a fee. Customers will be charged a fixed fee of 25 € + VAT for connecting 1 KW monophase and triphase electricity and for electricity consumption. During the mounting of the exhibition stands, only those Customers that have paid their electricity fees until the deadline indicated by SEKTÖREL FUARCILIK will be provided electricity. All these technical connections to the stands will be carried out only by SEKTÖREL FUARCILIK. Any damage to the installment materials given to the Customer will be the responsibility of the customer. Any damage incurred due to uncontrolled energy utilization will be the responsibility of the Customer.

Water connection and usage charge is 200 € +VAT, compressed air connection and usage charge is 150 € +VAT.

Electricity, air and water connections of companies that haven't paid the electricity, air and water connection charges are not going to be realized.

Article 39: SEKTÖREL FUARCILIK will be fully authorized for all issues starting from the entry of the Customer into the venue until the Customer's exit. SEKTÖREL FUARCILIK's right to give orders is reserved. Items will enter and exit the venue only in accordance with the schedule provided by SEKTÖREL FUARCILIK.

Article 40: The infrastructure services required for erecting the stands are present in the bottom of the Exhibition base. Before starting erecting the stands, the customers should make these services available in the stand area, and then should leave guides between the stands and the channels, without obstructing other infrastructure works. Also, the Customer is recommended to communicate the details of the technical infrastructure, to the architecture company that the Customer works with.

Article 41: SEKTÖREL FUARCILIK has the right to change the location and date of the exhibition in case the exhibition cannot be started due to conditions outside the control of SEKTÖREL FUARCILIK or conflicts with the company that the venue is leased from or due to court cases or any extraordinary conditions beyond SEKTÖREL FUARCILIK's control.

Article 42: SEKTÖREL FUARCILIK has provided the payment plan for the 21st International Energy and Environment Exhibition and Conference in Form F2. Exhibition Participation fee indicated in the agreement will be paid in cash to SEKTÖREL FUARCILIK on the indicated date/dates. These amounts will be invoiced based on the TL (Turkish Liras) equivalent of the amounts as calculated on the basis of Effective Foreign Exchange Rate of the Central Bank of Turkish Republic on the invoice date. VAT amount of 18% will be added separately. For payments made 10 days after the invoice date, interest will be charged for the number of days between the original invoice date and the payment date. Payments will be transferred to the bank accounts of SEKTÖREL FUARCILIK as indicated in Form F2.

Article 43: The items displayed in the stands should be licensed. The Customer will have full responsibility in case of a trademark or copyright violation related to titles, products, brands or services presented at the exhibition space or any spot inside the venue. Additionally, SEKTÖREL FUARCILIK will in no way be responsible from any violation of the trademark or copyrights of 3rd parties in relation to the items displayed at the stand or activities of the Customer inside venue and in case SEKTÖREL FUARCILIK becomes the addressee of any demand for compensation or legal penalty due to such violation and has to make payments, SEKTÖREL FUARCILIK will have the right to demand the compensation of these amounts including any interest from the Customer.

Article 44: Stamp tax related to this participation agreement will be paid equally by the Customer and Sektörel Fuarçılık in accordance with relevant procedures.

Article 45: In line with law numbered 5174 about the procedures and rules for the organization of exhibitions within national borders, SEKTÖREL FUARCILIK will act in accordance with the relevant provisions of the communiqué of the Union of Chambers and Commodity Exchanges of Turkey regarding venue security.

Article 46: All notifications as well as notifications that will place the other party at default or result in non performance by the other party should be notary certified. The parties hereby accept that any notification that fails to meet these criteria will not be valid and will not bear any legal consequence even though received by the other party.

Article 47: For any conflict that might arise from this agreement, the participant hereby accepts and declares that the books, records and computers of SEKTÖREL FUARCILIK will be binding and serve as definite proof and that the participant waives its objection and defense right related to them and its right to offer pledge to have SEKTÖREL FUARCILIK prove that SEKTÖREL FUARCILIK's records and books are kept appropriately. Company records and commercial books of SEKTÖREL FUARCILIK will constitute the only proof in line with Code of Civil Procedure.

Article 48: The parties hereby accept that they are commercial entities and this agreement is a commercial agreement and that in case of payment default and in all situations where one of the parties is the addressee of a demand for compensation, the parties can demand payment of interest and undertake to act as prudential commercial entities as described in Turkish Code of Commerce.

Article 49: The parties accept that this agreement will be implemented in accordance with first of all the Turkish Laws and that Turkish Code of Commerce, Turkish Code of Obligations and relevant provisions in other Codes are legislation in force and in case of any conflict, The Courts of Turkish Republic and particularly Istanbul Central Court and Execution Authorities will be in charge.

Article 50: The company which arranges and signs this agreement with SEKTÖREL FUARCILIK is a corporation; the company representative signing under company seal on behalf of the Customer (the company) agrees and undertakes to act as the debtor and joint guarantor for all performances of the Customer.
